I further certify that my Harris Park property is not operated as a short-term rental, defined as a rental for any period of one day at any time during the year. I understand that if I submit this application and payment and it is later determined that my property qualifies as a short-term rental, no refund will be issued. Additionally, I acknowledge that I will be permanently prohibited from purchasing fishing badges in the future.
